Criteria for Reopening Schools

On July 13, 2020, Governor Cuomo announced new, data-driven guidance for reopening schools in New York State.

Schools in a region can reopen if that region is in Phase IV of reopening and if the daily infection rate remains below 5 percent, using a 14-day average since unPAUSE was lifted.

Schools will close if the regional infection rate rises above 9 percent, using a 7-day average, after August 1.

The Governor will make the determination regarding the reopening of schools sometime during the first week of August 2020.

The Mount Sinai District and Building Reopening Plans will be updated following the Governor's announcement.



Mount Sinai School District Reopening GOALS

- ➤ Health, safety and well-being of students, staff and community is paramount
- To return all students to in-person instruction on a consistent basis as soon as possible
- Need to consider 3 scenarios for reopening
 - ✓ All students In-Person
 - ✓ Hybrid Model- Combination of In-Person and Remote Learning
 - ✓ Remote Learning Model
- ➤ Provide supports for students/families and staff before/during/after reopening

Formal Guidance





Districts received formal guidance from the CDC, the NYS Department of Health and from the NYS Education Department.

Required for Reopening Schools

- **≻**Face Masks
- ➤ Social Distancing
- ➤ Daily Health Screenings
- Facilities, Hygiene, Cleaning and Disinfecting practices
- ➤ Working with local Department of Health
- ➤ Transportation- Changes
- ➤ School Meals- Changes
- ➤ Classroom-Changes

Face Coverings Masks

- To be worn at all times by all individuals.
- Mask breaks will be given when students are socially distanced and seated at their desks or eating during meals
- Masks must be worn on the school bus
- Students and staff will bring masks from home.
- Masks should cover both the nose and mouth.
- Replacement masks will be available if someone forgets or soils their mask.

Social Distancing

- 6 ft. of space between individuals is needed in classrooms
- Certain activities have a mandate of 12 ft. for social distancing (Singing, woodwind instruments, certain physical activity)
- Every classroom will have 12-20 students (depending on room size)
- Remove all non-essential equipment and furniture from rooms to maximize space
- Use alternative spaces to provide sufficient room for instruction
- Appropriate spacing for seating in cafeterias and auditoriums
- Some Hallways/Stairways will be designated as One-Way passage
- Exploring use of outside areas for meals weather permitting



Daily Health Screenings



- Daily Health Screening Questionnaire for staff and students
- Daily Temperature check of each individual prior to entering building
- Temperature check may be done at-home
- If student has a temperature of 100 or higher, do not send them to school!
- If a student develops a temperature while at school, they will go to nurse/designated area and remain with staff until picked-up from school



Facilities, Hygiene, Cleaning and Disinfecting Practices

- Students and staff will be instructed in proper hand and respiratory hygiene
- Regular cleaning of restrooms, frequently touched surfaces(care tables, counters, door handles etc.) throughout the day
- Custodians will maintain cleaning logs for the areas to which they are assigned
- Drinking fountains will be closed. Bottle refilling stations will remain open
- Increased ventilation



Working with Suffolk County Department of Health

- District must work with the local DOH to develop plans for when a staff member or student tests positive for COVID-19
- District will coordinate with DOH regarding Stay-home guidelines, school closure and quarantine measures
- Coordinate with DOH regarding Contact Tracing
- District must have flexibility to adapt to regional changes in COVID-19 status

Transportation



- Masks must be worn by all individuals on the School bus.
- Number of students on the bus will be decreased to allow allow for social distancing
- Household members are welcome to share the same seat on the bus

School Meals

- Social distancing will be required during meals as students may eat without masks
- No buffet style meal service is permitted
- Pre-packaged lunches will be provided
- Students are welcome to bring lunch from home
- Students eligible for free or reduced lunch will be provided school meals on a daily basis- whether they are In-Person or Remote Learning
- When Meals are provided in the Cafeteria or other shared spaces, all tables, chairs, surfaces will be cleaned and disinfected prior to the next group of students



Classrooms



- Desks will be arranged 6 ft. apart for social distancing
- All non-essential furniture and equipment will be removed to add space
- Windows can be opened for increased ventilation
- Students will be provided mask breaks when seated at their desks

Instruction

Focus on:

- Core Instruction
- Assessment of Achievement
- Recovery of Skills
- Subsequent Progress and Growth
- Continued Social Emotional Well-Being

In-Person Model

Mount Sinai School District's goal is to return all students K-12 to inperson instruction on a daily basis

However

Given the nature of COVID-19 and the need to follow mandatory guidelines for reopening, the buildings in the district need to initially prepare for a hybrid model

In-Person and Hybrid Models

As of July 31, 2020

The District is actively working to have Grades K-5 return to In-Person instruction four or five days per week.

Challenges include:

- > Space (large enough to allow for mandated social distancing)
- >Fiscal
- ➤ Availability of Personnel

Hybrid Model

As of July 31, 2020

- Kindergarten students will be able to attend In-person instruction four days per week. (room and class size allow for social distancing)
- Students receiving special education programs in self-contained classrooms Grades K-12 will be able to attend in-person instruction four days per week (class sizes of 15 or less and room size allow social distancing)
- Grades 1-12-Students will be assigned alphabetically to a cohort A or cohort B
- Each cohort will attend In-Person instruction two days per week and Remote Instruction three days per week.
- Students from the same household will be assigned the same cohort even if last names differ

- Parents may view a PowerPoint and Instructional video regarding the use of Google Classroom on the District's website.
- In-Person Parent Google Parent Workshops may be scheduled pending reopening
- Documents related to the expectations for stakeholders engaged in Remote Learning are posted on the District's Website.

Other Considerations

- Field Trips- At this time, field trips are canceled until further notice.
- Co-curricular Activities: Determinations regarding co-curricular activities (i.e. clubs, intramurals) will be made on a case by case basis.
- Athletics: The District will abide by determinations made by NYS Public School Athletic Association and/or Section XI regarding Athletics.
- All large group events have been canceled until further notice.
- There will be no community use of facilities until further notice.
- Districts are mandated to limit on-site interactions (e.g., designating separate ingress or egress for faculty and staff, eliminating bidirectional flow of individuals to the extent practicable). As a result, we will limit visitors to essential and/or necessary functions (i.e. picking up your child).
